### Canada - Official Application Processing Times

Last updated on 1<sup>st</sup> July 2011

Please note: These processing times are provided as an indication only and are subject to change at any time without prior notice. Please contact your assigned Migration Consultant for details.

#### Skilled Workers

Skilled workers are people selected as permanent residents based on their ability to become economically established in Canada. Federal skilled worker applications are assessed for eligibility according to the Following criteria;-

For your application to be eligible for processing, you must:

- include the results of your official language proficiency test, **AND**
- have a valid offer of “arranged employment”, **OR**
- have one year of continuous full-time paid work experience in at least one of the occupations listed below.

If you meet the above minimum requirements, your application will be processed according to the six selection factors in the skilled worker points grid: - your education, your abilities in English and/or French (Canada’s two official languages), your work experience, your age, whether you have arranged employment in Canada, and your adaptability. You must also show that you have enough money to support yourself and your dependants after you arrive in Canada.

**Note: At present the pass mark for Skilled Worker applicants is 67 points, and for Business migrant is 35 points**

If you are applying under one of the 29 eligible occupations (see below), between 1st July 2011 and 30 June 2012, a maximum of 10,000 complete Federal Skilled Worker applications will be considered for processing. Within the 10,000 cap, a maximum of 500 Federal Skilled Worker applications per eligible occupation will be considered for processing within this same time frame. These limits do not apply to applications with an offer of arranged employment. Once each specific occupation cap has been reached, CIC will only accept applications for that occupation from people with an existing offer of arranged employment.

\*\*\*For those who had lodged their application before 1st July 2011, the processing times have still to be advised. New federal skilled worker applications that do not meet the eligibility criteria outlined above will not be processed and the application fee will be refunded by Citizenship and Immigration Canada.

### Average Processing Times – In Canada

For permanent residence applicants resident in Canada (for temporary lawful resident only) applying under Skilled Migration, Business migration, Spouse Migration or Parent Migration, applications should first be sent to the Centralized Intake Office in Sydney, Nova Scotia. Following their acceptance, applications are processed at the Canadian Consulate in Buffalo, USA.

Business Migration (Investor)	14 – 35 months (6 – 19 months for Quebec)

Temporary (student)	62% processed in 28 days or less
Temporary (work permit)	75% processed in 28 days or less

#### Notes:

- 1) Processing times based on 80% of applicants receiving their visas in the time – except for Business Migration where range is given for 30% to 80% of applicants.
- 2) Skilled Migration times apply as long as applicants have satisfied 1 or the above 3 criteria.
- 3) Parents & Grandparents times do not include sponsorship processing time.
- 4) If shown N/A – an office has finalised less than 10 cases in the last year.
- 5) Times for temporary work permits do not include the time required to obtain a labour market opinion from Service Canada).
